SCHOOL SPORTS PERMISSION SLIP

Dear Parents,

Somerdale Park School will have a competitive school sports soccer program again this year. If your child is interested, please fill out the next page of this notice and return it to school by: **AUGUST 15th (same due date as physical)**. If your student is selected for the team, transportation for away games is provided. ***** Academics and Effort standards must be met. All grades will be checked.**

Students representing Somerdale Park School are expected to represent the school in a manner that reflects positively about the community. It is for this reason that the following will need to be implemented with the cooperation of coaches, players, parents and staff. Any student who violates any of the following rules will be subject to a minimum of one game suspension which shall include not attending the game as a spectator, to suspension from after-school activities for the rest of the year.

1. Damaged or unlawfully acquired school property.
2. Damaged or unlawfully acquired personal property.
3. Caused physical injury to another student.
4. Possessed dangerous objects.
5. Possessed, used, sold, furnished drugs or alcohol.
6. Possessed, used, sold, furnished tobacco.
7. Obscene act, profanity, vulgarity.
8. Disrupted school activities, defied authority.
- 9. Student must not be on the No Activities List (D and F).**

Procedure for implementation:

1. Student conduct shall be monitored at all times by coaches, parents and staff.
2. A person may ask the student's behavior be brought to question before a committee which shall consist, at a minimum, of the school principal or designee, the coach and when appropriate, a teacher, within 5 calendar days from date of occurrence.
3. The student will be told of the reason for the referral and asked to present his/her side of the story.
4. The committee will look at all matters pertaining to the case and deliberate in private without the student being present.
5. The student will be told of the committee's decision and the date on which the disciplinary procedure will be in effect.

Notwithstanding the above, the student shall have the right to redress as outlined in Board Policy. It shall be understood, however, that the action taken by the committee in regards to discipline shall be carried out as soon as possible, regardless of the appeal process. **Also be advised that siblings who are not signed up to participate are NOT ALLOWED to be present at meetings and/or practices. Please see attached letter.**

Students may not be involved in school sports until they have returned the form on the next page.
